

and staying connected with




"A hot meal is the least we can do to give our thanks," said Loop. "An enjoyable summer meal is a small way to relay our appreciation of their dedication and work."



ifeSpire is proud to highlight Mary Ann Wilson, new resident at The Glebe. Mary Ann served as the Virginia State Director for the United States Department of Housing and Urban Development (HUD) beginning in 1990 where she held that role for over a decade. In 2001, Wilson was asked to take on a special assignment by a member of the United States President's Cabinet, the Secretary of HUD, as the new Acting Regional

Director of New York and New Jersey.

Just months after taking on the new role, Wilson would face the unthinkable as she and her team witnessed the tragic events of September 11, 2001, happening in plain view from her office on the 35th floor in New York City. Thanks to her instrumental role in ensuring the safety of her team and many others, Wilson was recognized with the prestigious Secretary's Award for Extraordinary Leadership.

Reflecting on that fateful day, Wilson vividly recalls the serene morning she experienced in New York City. Leaving her temporary accommodations in midtown Manhattan, she took the subway to city hall and then strolled to the federal building, where her office offered breathtaking views of the East River, with the Brooklyn Bridge and iconic twin towers just a stone's throw away.

At 8:46 a.m., Wilson and her colleagues were shaken by the tremors and the deafening impact of American Airlines Flight 11 crashing into the North Tower of the World Trade Center. Only 17 minutes later, a second plane struck the South Tower. In that harrowing moment, Wilson knew these events were no accidents. With composure and determination, she immediately ordered the evacuation of her team that was housed on several

floors. As she led the way down 35 flights of stairs, linked hand and hand with those around her, she remained a beacon of calm, providing the strength needed to quell fears and guide everyone to safety.


In the six months leading up to 9/11, Wilson had never seen an evacuation plan or had any kind of drill in what was one of the tallest federal buildings in the country. "Post 9/11, all government agencies were required to develop a continuity of operations plan as a guide in the event of future attacks, and the Richmond HUD office became a model for that initiative," stated Wilson. "In fact,



our office was selected as a national training site, where periodic tests continue today."

Mary Ann's unwavering bravery saved the lives of hundreds within her building. Her valiant efforts demonstrated courage and resilience in the face of unimaginable adversity.







akewood's apiary program has made quite the buzz since it began five years ago. Thanks to the unwavering dedication of several Lakewood residents, the program gained widespread support and approval. Today, the Lakewood Honeybee Club oversees the three hives nestled in the woods surrounding the campus and accessed by a beautiful cobblestone walkway to both the apiary and a private observation and reflection space with benches.

The hive trio, lovingly named Beetrice, Karla and Joan, gift the community with honey that is offered to residents in exchange for donations to support local charities, including the Richmond Alzheimer's Association. Last year alone, the program generated a remarkable 72 jars of delicious golden raw honey, each symbolizing the collective hard work of the bees and commitment from Lakewood's volunteer residents.

Lakewood's apiary program is so much more than a club activity.



It's also a platform for intergenerational connections to flourish. St. Michael's Episcopal School, a neighboring school, proudly houses its own beehive, providing students with a hands-on opportunity to learn the art of beekeeping. Earlier this year, the school's students were treated to a special visit to Lakewood, where they were enlightened

about the importance of bees in our ecosystem and secrets to maintaining healthy hives.

Prior to their visit, a pen pal program was established between these students and Lakewood

In January 1946, Culpeper was approved as a site to build a home for senior adults and the Certificate of Incorporation was signed and filed in the Culpeper Clerk's office March 25 of the same year. Originally registered as Virginia Baptist Home for the Aged, Inc., the charter was amended in 1954 to change the name to Virginia Baptist Homes, Inc. It was Dr. Edwards

who first introduced the idea of this home for senior adults to the Baptist General Association of Virginia. Over 75 years later, his vision continues to thrive and expand.

The J.T. Edwards Legacy Society was established in 1996 to honor those who support the legacy of Dr. Edwards through any form of planned giving, including bequests, charitable gift annuities, charitable remainder trusts or gifts of life insurance. These gifts provide us with the ability to plan for the future success of this ministry.

JTE Society members extend a lifetime of support through gifts, volunteer hours and membership. Like Dr. Edwards, these visionary individuals are leaving their own legacy for future residents of LifeSpire of Virginia and we are proud to honor them through membership in this society.

rowing up in St. Louis, Missouri, Rex Hogan never had a specific goal of what he wanted to be when he grew up. After high school, he started as an engineering student at Washington University in St. Louis, Missouri but then found a passion for computer programming and computer languages.

Rex served in the United States Air Force as a Civil Engineering Officer in both Florida and Alaska. It was in Florida where he met his bride, Cindy Hogan. He then took on a faculty role at the Civil Engineering School at Wright-Patterson Air Force Base (AFB) in Ohio. Once Rex left the miliary, he built his career as a computer scientist

working for TRW/Northrop Grumman and at Langley AFB.

While Rex is enjoying his retirement years, he still teaches as an Adjunct Professor in the Computer Information Systems department at ECPI University. In his role as an adjunct faculty member, Rex serves as an interface to Barbara Jackson-Ingram, Administrator of Health Services at The Chesapeake, and ECPI's Medical Career Institute for students looking for jobs.

Rex is influenced today by his wife and partner Cindy. "She is the sweetest and most caring person I have ever known," said Hogan. "She makes our house a home." She compliments him and will often work to pull him out of his shell and help him engage with their friends. Rex and Cindy chose The Chesapeake after a recommendation from their daughter and moved to the community in 2010.

While at The Chesapeake, Rex has served in various leadership and service roles to include President of Resident Council. In addition, he started The Chesapeake's "Geek Squad," affectionately called the Chesa-Geeks to help residents who need assistance with computers and technology.

Together, Rex and Cindy give back by sorting through resident donations for The Chesapeake's Fresh Start House, a place for team members to live when faced with financial difficulties.

When asked of what he is most proud, Rex says he is proud of his career and the impact of his contributions. He is particularly grateful for his time at Langley where he was able to help service men and women who were struggling with mental health challenges.



✓urtis Brooking was born and raised in Orange County, Virginia in a home built in 1848 by James Madison's great nephew. Curtis was influenced greatly by his father, Linwood "Link" Brooking, who managed both his own property and the Montpelier estate. Curtis says his dad was a caliber individual. full of common sense and used a practical approach in every part of his life. As he watched his father manage a multifaceted organization like Montpelier, Curtis felt inspired to be exactly like him.

Curtis's commitment to volunteerism came from his mother Mildred, who volunteered for community organizations such as the Red Cross, local nursing homes and their church. Her devotion to helping others provided an excellent example to her children. They learned that they too should give a portion of their lives to service and charitable organizations.

Curtis met his wife
Odile (Dee) while stationed
near Orleans, France. His
buddy set him up with Dee
on a blind date where they
ended up spending the
evening paddle boating.
Curtis and Dee dated for
over a year while he was
in France and then they
were married before he
was transferred to Augusta,
Georgia to serve as a
military instructor.

Today Curtis is influenced the most by his wife, his pastor, Reverend Dan Carlton and Reverend Hans Murdock, Chaplain at The Culpeper. Curtis served on the nominating committees for both Dan and Hans and admires them both for their service to the community using the gifts that God has given them.

Curtis served as a Virginia Baptist Homes (VBH) trustee, Vice-Chairman and other leadership roles to include strategic planning, marketing and nominating committees.

Curtis and his wife Dee moved to the Culpeper in 2015 and look forward to offering continued support for community activities through teaching, assisting with functions and encouraging others to become more involved.
